In consideration of your acting as our Portfolio Manager under the terms and conditions of the Non Discretionary Portfolio Managerment Agreement dated________(the "Agreement"), and for settlement on demand of all amounts due or which hereafter may become due from me/ us to you, as well as for settlement on demand of all interest thereon at the rate or rates that you may from time to time determine as payable thereon and all costs, charges and expenses, I/ we hereby declare pledge and declare as follows:

- 1. I/ We pledge with you as security for repayment to you all shares, stock and securities with transfer forms duly signed in blank and/ or securities duly endorsed in your favor which I/ we now deposit or which I/ we have deposited with you or which is in your possession held on my/our behalf and also all shares, stocks and/or securities which I/we may hereafter deposit with you in adddition to or in substitution for the shares, stocks and/or securities already deposited or which may hereafter come into your possession on my/our behalf.
- 2.
